## **TERMS AND CONDITIONS**

Persons having personal account with Green Development Bank Limited may avail ATM Card facility from the Automated Teller Machine in branches and any ATM under SCT Network by using Green Development Bank Limited. Debit card Subject to the following terms and conditions.

- The Card and personal identification number (PIN) issued to the card holder are entirely
  at the card holders' risk and responsibility. The card holder undertakes full responsibility
  for any and all transactions make by the use of the card whether or not made with
  his/her knowledge or authority.
- 2. The card is not transferable and shall be used exclusively by the card holder.
- The Cardholder will be provided the facilities of cash withdrawals within the arranged limit, balance enquiry, make payment for the purchase to the merchant through point of sales (POS).
- 4. The card holder shall provide written information to the bank for the lost/stolen, damage of card and disclosure of PIN. The cardholder will be liable for all the transaction prior to the notification.
- 5. The bank reserves the right to limit daily card withdrawal by the cardholder. Cash withdrawal from ATM will be disposed only in NRs. 500 and NRs. 1,000 denominations or in any other denominations as decided by the bank management.
- 6. The Bank shall debit the designated account for all fees and charges as determined by the bank related to the card and the services thereby provided.
- 7. The charges will be applicable as per the standard charges of tariff approved by the bank to the card holder.
- 8. Wrong entry of PIN for three consecutive times while making cash withdrawal will automatically make card in operative. In such cases the card holder will have to contact the concerned authority of the bank.
- 9. The bank reserves the rights to seize/cancel the card in case of submission of false information or the misuse of the card.
- 10. The bank will not be responsible in any way for non-availability of ATM services or POS terminal at merchant outlets for any reserve whatsoever and howsoever arising as a result of malfunctioning of card of ATM, mechanical or power failure or otherwise.
- 11. The card is the property of the bank at all times.
